DLJ Opdyke (1972) FCT 20 found that the Tagetes oils from T. minuta and T. patula are non-toxic, non-irritant and non-sensitising. The photo-toxicity of the oil has lead to IFRA recommending that the concentration of tagetes oil be limited to 0.25% where the skin is exposed to the sunlight (this does not apply to usage in products wich are washed off the skin such as bath.)
